I am to inform you that the online submission of application form for admission to do Ph.D. programme for **July 2021 Session** will be opened in the University website [www.unom.ac.in](http://www.unom.ac.in) and it will be available from **06-07-2021** to **05-08-2021**. Candidates who desire to get admission for **July 2021** session are directed to submit the application forms through online from the University website and the hard copy of the filled in application forms should be submitted to the concerned University Departments / Affiliated Colleges / Research Institutions where they are proposed to undergo their research work along with the prescribed fee of Rs.500/- through online payment. The Scheduled Caste / Scheduled Tribe of Tamilnadu candidates alone are exempted from paying the application processing fee and that they should send the copy of the proof at the time of submission of applications.


I am further to inform you that the **Departmental Selection Committee** should be **convened only after the last date of receipt of applications** from the candidates for **July 2021** session i.e. **05-08-2021** and the **Entrance Examination should be conducted within the stipulated time (i.e. 06-08-2021 to 05-09-2021) only**. After 05-08-2021 a separate page will be opened in the University website and the Supervisors should submit the required informations through online by using the candidate's application number as user-id and DOB of the candidate as password and the hard copy of the Supervisor's details along with the application form, Minutes and enclosures should be sent to the University on or before 05-09-2021. The applications received after the stipulated time i.e. after **05-09-2021** will **not be considered** for admission in **July 2021** session.

**NOTE:**

1. **Hard copy of the application should be submitted to the respective University Departments / Affiliated Colleges (Autonomous and Non- Autonomous) / Research Institutions on or before 05-08-2021.**
2. **Supervisor's details should be furnished through on-line by using Candidates application Number and DOB [DD/MM/YYYY] as User-id and Password.**
3. **The University Departments /Affiliated Colleges(Autonomous and Non- Autonomous) / Research Institutions should send the hard copy of application forms and Supervisor details along with the Minutes and enclosures to the University on or before 05-09-2021.**
4. **The online application designed for the July 2021 Session alone will be accepted and other applications will not be considered under any circumstances.**
